FERRET SALES CONTRACT

- 1) Purchaser agrees that all ferrets will be handled in a loving, gentle manner by all members of my household and guests that visit my home. Said ferret will be fed quality dry grain free kitten/ferret food and fresh water (whole prey, balanced raw and freeze dried foods also encouraged). Ferret will be kept indoors in a clean and healthy environment and housed in a size appropriate cage or ferret proofed room when no one is at home or can supervise the ferret's activities. Purchaser will have ferret proofed their house to the best of their abilities and have done appropriate research on the special care and needs for ferret ownership. The ferret will be provided with attention, companionship, exercise and discipline.
- 2) If purchaser is unable to spend quality time with the ferret, wish to sell or unable to keep him/her as a pet, be suspected of abuse or improper treatment of said ferret, in violation of this contract, have to give him/her up for any other reason, Scarlett's Happy Dookers(SHD) will be notified first. SHD may reclaim the ferret and/or refuse the resale of such ferret. IF SHD allows the sale of the ferret and does not reclaim the ferret, SHD is to be provided all know information about the new owner. Purchase price will not be refunded.
- 3) Purchaser understands that the refund of purchase price is guaranteed up to **fourteen (14)** days from purchase date with return of said ferret in the same condition in which it left **SHD**. After which date, any refund may be contingent upon the resale of said ferret unless a **prior** agreement has been made. The exception being for a ferret sold out-of-state or over 100 miles from Ferretry, then refund is guaranteed only upon **completed** arrangements for return by purchaser of said ferret to Ferretry or a designated person to within a 100mile radius of Ferretry. Refund may be subject to the deduction of a transport fee and will reflect any discounts.
- 4) If said ferret's health/welfare is ever in question, purchaser agrees to seek veterinary advice and care in a timely manner. At no time will the ferret be **declawed, canines/incisors removed or anal gland removed (descended)** unless for a medical reason and must be discussed with **SHD** first. If a health issue does come up, the purchaser is encouraged to contact SHD with any questions or concerns.
- 5) Said ferret's health, if bred by SHD, is guaranteed for up to one year old. If, during that one year, said ferret is found to have a genetic fault, congenital health disorder or passes away through no neglect or mistreatment, said ferret will be replaced when proof of such disorder is presented. (i.e. statement from a licensed vet and a completed necropsy may be requested if the ferret dies) Ferret may be kept or returned to the breeder. All items covered under the health guarantee are by replacement only. No refunds. SHD will not be responsible for any medical expenses incurred. The owner realized that owning a ferret means trips to the veterinarian and understands that he/she will be responsible for all payments.

This guarantee applies to the original owner only and is nontransferable to a second party. No replacement ferret will be given if the ferret has been bred or euthanized without SHD's permission. The replacement ferret will be mutually agreed upon by both parties and will be of comparable quality. It is understood that the replacement ferret may not be from the exact same litter as the original ferret and may have to be from a future litter.
- 6) The ferret will receive all proper vaccinations, timely medical attention, and maintenance/grooming to insure a healthy happy pet. If purchaser is a resident of county or city that requires a current Rabies vaccination, said vaccination should be obtained after the age of 12 weeks. After the initial Distemper kit series, a booster at 12-18 months intervals is highly encouraged until the ferret is over the age four(4).
- 7) The purchaser understands that the purchase price includes a series of two (2) canine distemper shots **ONLY** if brought back to breeder. Purchaser agrees to complete the series of shots on the dates designed below as needed. Depending on date of transfer, ferret may also have a current rabies and Aleutian Disease Virus (ADV) test result.

8) The purchaser agrees that this ferret was:

_____ purchased as **PET ONLY** for _____ and agrees to have the ferret altered or Deslorein implant by 12 months. Hobs no sooner than 8 months old, jills no sooner than 5 months. Recommend jills at 6-8 months of age (prior to first heat cycle) and hobs at 10-12 months. If jill does come into heat prior to spaying and jill is brought to SHD, SHD will give a hormone shot to take out of heat so she can be spayed while not in heat. A copy of the veterinarian bill as proof of spay/neuter or implant of said ferret by a licensed veterinarian must be sent to SHD within **sixty (60) days** from date of spay/neuter.

Owner furthermore agrees that said ferret will **NOT** be bred. *If owner wishes to breed said ferret, owner MUST contact the Breeder prior to breeding, get approval in writing and pay an additional \$100 breeder fee. (New owner initial _____)*

The owner/purchaser agrees that he/she understands this contract fully, and that this contract is under the jurisdiction of the State of Ohio, in the county of Delaware. It is agreed that the place of venue shall be Delaware County, Ohio. The undersigned understands this agreement is a legally binding contract and agrees fully to the conditions set forth in this contract.
